**Subject: Upcoming surveys - Morgan and Morecambe Offshore Wind Farms: Transmission Assets**

To Whom it May Concern,

We are writing to inform you of upcoming ground investigation and environmental surveys as part of the Morgan and Morecambe Offshore Wind Farms: Transmission Assets ('the Project').

The purpose of the surveys is to gather the necessary data and to better understand the condition of the ground at various locations along the proposed onshore route. The results of the surveys will be used to further develop the design of the Project.

Where access to land is required, our land agent Dalcour Maclaren has, or will be, in touch with those landowners to seek the relevant permissions. Please be assured that these surveys do not constitute the start of any construction work.

### **About the Project**

The Morgan Offshore Wind Project, (a joint venture between bp and EnBW Energie Baden-Württemberg AG) is being developed by Morgan Offshore Wind Limited, and Morecambe Offshore Windfarm (a joint venture between Cobra and Flotation Energy Limited), is being developed by Morecambe Offshore Windfarm.

The two proposed offshore wind farms are collaborating to develop the Project, which will connect the two offshore wind farms to the national grid substation in Penwortham. The wind farms are expected to form a key contribution to the UK's target of generating 50 gigawatts (GW) of power from offshore wind by 2030 and combined will generate approximately 2 GW of energy.

## **Timeline for ground investigations and surveys**

From April 2024, we expect mobilisation activities to begin. This will include setting up temporary site compound(s). The surveys will then start shortly thereafter, and we expect for all works to be completed by June 2024. This will include reinstatement and removal of all equipment from site. Please note that these activities are subject to weather conditions and therefore some dates may change at short notice.

Our working hours will be Monday to Saturday between the hours of 8am and 6pm.

During the surveys you may notice the use of equipment, such as excavators, drill rigs, dumper trucks and tractors. Please be assured that the teams on site will aim to keep disruption to a minimum.
